Commenting on the condition of the road, the managing director of OGFZA, Mr Umana Okon Umana, said apart from its adverse impact on existing businesses in the axis, the logistic crisis caused by the failed section of the road could seriously curtail the inflow of foreign direct investment which the Federal Government has been campaigning for. "No foreign investor wants to stake his money where he cannot have access to," Umana said.

The OGFZA managing director said that he has drawn the attention of the Minister of the Niger Delta Affairs and the managing director of the Niger Delta Development Commission (NDDC) to the condition of the road, commending the NDDC for its intervention. Umana

Low cost power soon for Onne Free Zone

A major relief is coming the way of investors in the Onne Free Zone as the regulatory agency of the zone, the Oil and Gas Free Zones Authority (OGFZA), partners an investor to roll out embedded power in the enclave within the next eight months.

Addressing investors in the zone and other stakeholders at a joint stakeholders' forum on improved service delivery in Onne on Wednesday, the managing director of OGFZA, Mr Umana Okon Umana, said the move was aimed at reducing the cost of doing business in the zone.

"In order to reduce the cost of doing business in the free zones regulated by OGFZA we are partnering with an investor to provide embedded power supply in Onne Free Zone within the next eight

months," Umana said. "We are also seriously addressing the challenge of high cost of doing business in the free zone arising from other tariffs. We have engaged all the stakeholders in this regard, including developers of the free zone and the IOCs, all of who have agreed that the tariffs are way too high and must come down. In this regard, the Authority in line with the extant law and regulations will soon be issuing a new schedule of tariffs which would be applicable in the free zones."

Umana, who reported other successful OGFZA initiatives to the forum of stakeholders, described the efforts as the fulfilment of the commitments in the roadmap of the agency which was drawn up early in the year. "I am happy to report

also, he said, "that in March this year the Authority in compliance with the extant law and regulations implemented a modified Standard Operating Procedure to enhance transparency, accountability and efficiency. "Furthermore, in line with the commitment made in our Roadmap we have begun the full automation of our processes with the deployment of the Oracle Cloud application for all aspects of our operations. The deployment of the application and the training of staff to operate it are ongoing.

"When it is fully operational, the Oracle application would make it all too easy to achieve our set goals of meeting a new licence request within 14 days and a renewal request within 48 hours."

OGFZA partners Customs on service delivery



The Oil and Gas Free Zones Authority (OGFZA) and the Nigeria Customs Service (NCS) are committed to working together for improved service delivery to clients in the nation's free trade zones, authorities of both agencies of government have said.

Addressing a joint stakeholders' forum of the two agencies in Onne, Rivers State, organised to fine tune a pathway to better service delivery in the free zones, the managing director of OGFZA, Mr Umana Okon Umana and the Comptroller-General of the NCS, Col. Hameed Ali (rtd), said their agencies were united by the collective objective of delivering best-in-class services to investors in the free zones in line with the Ease of Doing Business policy of the Federal Government.

Umana explained further: "This conference is jointly hosted by the Oil and Gas Free Zones Authority and the Nigeria Customs Service to underscore the fact that the Ease of Doina Business initiative is a national Policy under one Government, by which fact all relevant agencies of Government are to work together in implementing the policy to deliver efficient services to the investor. That is both the letter and spirit of the policy, whose urgency has been reinforced by the Executive Orders issued by the Acting President, Professor Yemi Osinbajo." Umana added that agency cooperation for efficient service delivery under the one-government concept is operationalised in the free zones through the one-stop shop policy, which obligates

all relevant agencies of government to work through OGFZA to optimise and expedite service delivery. "The point being made here is that the policy of efficient service delivery has to be imbibed and made a way of life across all agencies of Government," he said.

In his remarks, Col. Ali, comptrollergeneral of Nigeria Customs, declared that the service was committed to working with OGFZA for the good of the nation. "We recognise the need to work with you and carry you along in our match toward evolving an efficient and responsive service," the comptroller-general said.

Col. Ali explained that full engagement with all stakeholders in the oil and gas trade is a requirement for the success of the industry.

The forum, which drew participation from licensed customs clearing agents, free zone investors, relevant government officials, and other stakeholders, was highly interactive. It featured the presentation of technical papers on the Ease of Doing Business by Mr Adekunle Ajayi, OGFZA's head of operations and technical services and another paper providing the customs perspective on improved service delivery in the free zones by Abubakar Bashir, who is the customs comptroller in charge of Port Harcourt area command, Onne.

OGFZA to issue lower tariffs for Free Zones soon.

The Oil and Gas Free Zones Authority (OGFZA) is working to give effect to the policy of the Ease of Doing Business by seriously addressing its cost component through a significant reduction in tariffs applicable in the free zones. Speaking at a stakeholders' forum on improved service delivery jointly organised by OGFZA and the Nigeria Customs Service (NCS), the managing director of OGFZA, Mr Umana Okon Umana, said the cost of doing business in the free zones was way too high and had to come down.

"We are seriously addressing the challenge of high cost of doing business in the free zone arising from other tariffs," Umana said. "We have engaged all the stakeholders in this regard, including developers of the free zone and the IOCs, all of who have agreed that the tariffs are way too high and must come down.

"In this regard, the Authority in line with the extant law and regulations will soon be issuing a new schedule of tariffs which would be applicable in the free zones." Umana has consistently sought reduction in the cost of doing business in the free zones. arguing in each instance that high tariffs ultimately cancel out the incentives which OGFZA provides for the free zone investors. As part of the drive for lower costs in the free zones, OGFZA is rolling out embedded power in the Onne Oil and Gas Free Zone within the next eight months through a partnership with a private investor. "In order to reduce the cost of doing business in the free zones regulated by OGFZA we are

partnering with an investor to provide embedded power supply in Onne Free Zone within the next eight months," Umana said.

According to the OGFZA managing director, the cost of a unit of electricity from the embedded power infrastructure is expected to be significantly lower than the cost of energy being paid by investors under the current arrangement.

Also addressing the joint stakeholders' forum, the comptroller-general of the Nigeria Customs Service (NCS), Col. Hameed Ali pledged to partner OGFZA to meet Federal Government development objectives in the oil and gas industry as expressed in existing policies like the Ease of Doing Business and the Economic Recovery and Growth Plan.

Col. Ali explained that achieving improved service delivery in terms of timely clearance of goods from the ports in the free zones and other measures of efficiency depends on "honest customs declaration by traders, proper utilisation of temporary importation permits, strict compliance with free trade regulations and prompt perfection of declarations on provisional release procedure."

He stressed the importance of continuing engagement with all actors in the international trade chain to engender syneray and achieve success.
