OGFZA TO FAST-TRACK BOG CITY TAKE-OFF

Gas Free Zones Authority (OGFZA) has commended the executive management of the agency for effective leadership. The chairman of OGFZA's board, Chief Timipre Sylva, former governor of Bayelsa State, said during the inaugural meeting of the board of the agency at the Oil and Gas Free Zone, Onne, Rivers State, that the managing director of OGFZA, Mr. Umana Okon Umana, has demonstrated the right leadership in directing the affairs of the free zone regulator and in administering the oil and gas free zones under his control.

"Umana is leading OGFZA in the right direction," Chief Sylva said.

he Governing Board of the Oil and In a media chat after the meeting, Chief Sylva outlined the vision and agenda for the new board. "One of the things we would like to achieve is to be able to provide power in Onne," Chief Sylva said. "We are engaging a group of investors that will build a turbine for the free zone; that would be one of the things we would like to achieve before the end of the year."

TERMINAL OPERATORS WANT GOVT TO DREDGE ONNE CHANNEL

erminal operators in the Oil and Gas Free Zone, Onne, have called on the Federal Government to dredge the Onne Seaport and its channel leading out to sea in order to ease up the passage of big cargo vessels and cut operating cost.

The branch manager of Brawal Oil Services Nigeria Limited, Mr. Sylvester Uzoma Agbotian, who made the call during a facility tour of the zone by the governing board of the Oil and Gas

Free Zones Authority (OGFZA) said the operators and ancillary businesses at the depth of the seaport stands at 9.5 draft in low waters, which does not allow big vessels to berth at the Onne seaport, thereby forcing importers and exporters to incur extra cost by transporting their cargoes in bits with smaller vessels to and from the mother ships.

The shallow depth of the Onne Seaport, they said, also forces big ships to divert to other ports, thereby leading to loss of business and revenue to terminal port.

Mr. Sylvester Uzoma Agbotian, however, commended the management of OGFZA for providing a level playing field for all investors in the free zone. The Brawal branch manager told the OGFZA Board chairman and members that since the new management of the Authority led by Mr. Umana Okon Umana as managing director came on board, it has rolled out a set of policies

OGFZA, CUSTOMS TO OPTIMISE EFFICIENT SERVICE DELIVERY IN FREE ZONES

he Oil and Gas Free Zones Authority (OGFZA) and the Nigeria Customs Service (NCS) have signalled plans for greater cooperation between the two agencies for more efficient service delivery in the nation's oil and gas free zones.

Speaking during a visit to the offices of OGFZA in Onne, Rivers State,

representatives of OGFZA and NCS said greater collaboration through the one-stop-shop strategy and the pursuit of efficient service delivery were in the interest of the Federal Government's policy of the Ease of Doing Business in Niaeria.

The NCS visit was on the side-line of its study tour of the agency's command in Rivers State.

Addressing the management team of OGFZA, Mr. Wale Adeniyi, the Customs Comptroller who led the NCS delegation, said the visit was to help improve their "understanding of the objectives and operational procedures of OGFZA."

Mr. Adekunle Ajayi, OGFZA's head of operations and technical services, who

The Board is chaired by His Excellency, Chief Timipre Silva, former governor of Bayelsa State.

Other priority engagements of the new Board would be the provision of cheap power for the free zone in Onne; resolution of inter-agency conflicts involving OGFZA and other federal agencies; linking the free zones with railroads; strengthening the capacity of OGFZA to raise its IGR profile and adequately execute its mandate.

Processing Zones Authority (NEPZA) and OGFZA. "That will take a lot of our attention because we are going to make sure that we resolve those issues of conflict," Chief Sylva said.

The board chairman noted that the BOG City "was approved and licensed as a free zone a long time ago," adding, "We have to make sure that Brass Oil and Gas City becomes operational as soon as possible."

Observing that the governing board had little time in the face of so much to do, Chief Sylva said the situation called for hard work and firm prioritization in project execution.

He said the task the board has set for itself would be accomplished because of its high quality membership.

"I am very proud to be part of the board of such eminent Nigerians," the OGFZA board chairman said. "We are all very seasoned people, very skilled people and it is easy for us to understand ourselves."

SYLVA ASSUMES DUTY AS CHAIRMAN OF OGFZA

Chief Timipre Sylva is the current University of Agriculture, Chairman of the Board of Directors of the Oil and Gas Free Zones Authority. He was appointed by the President, HE Muhammadu Buhari and was inaugurated on 1 March 2018.

Chief Sylva hails from Okpoma in Brass Local Government Area. Bayelsa State. He was the former Governor of Bayelsa State (2007-2012).

He started his working career with the National Minority Business Council,(Nigerian branch of a New York based NGO), where he served as Executive Secretary from 1981 to 1991.

He was a former member of the Rivers State House of Assembly and Chairman Committee on Public Accounts (1992-1993). He was Managing Director, Joint Oil Services Limited (1994-2000) and former member of the Governing council, Federal

Umudike in Abia state till 2004. He also served as the Political Adviser to the Governor of Bayelsa State (2000-2001), Special Adviser to the Governor, Bayelsa (2001-2002) and Special Assistant to the Minister of State, Petroleum Resources (2003-2006).

He earned a degree in English Language/Linguistics from the University of Port Harcourt where he graduated in flying colours as the Best Graduating Student of the year 1986.

Chief Sylva has made remarkable contributions to the economic growth and development of Bayelsa State and Nigeria at large.

stood in for Mr. Umana Okon Umana, managing director of OGFZA, briefed the NCS team on the mandate, objectives and operations of OGFZA, informing them that the Authority was established by ACT No. 8 of 1996 to license and regulate oil and gas free zones in the country.

Mr. Ajayi said the principal mandate of OGFZA is to attract investments, particularly foreign direct investments (FDI), into the free zones and thereby generate jobs for Nigerians and revenue for government.

He explained that OGFZA has so far discharged its mandate creditably, having attracted over time more than 200 companies from 45 countries across the world, which have brought in about \$20 billion in FDI and created more than 100,000 direct and indirect jobs.

Mr. Ajayi also briefed the NCS team on the incentives provided by law for investors in the free zones, including Custom and Immigration wavers; zero federal, state and local government taxes; 100 per cent repatriation of profit and capital; as well as

fast-track clearing procedures.

The meeting discussed issues of security and further collaboration with regard to data sharing and warehousing, capacity building and effective implementation of the Executive Order on the Ease of Doing Business in the Free Zones.
